Nearly 48 million medical claim attachments are generated in the U.S. each year, with 94% of those submitted using inefficient manual processes.<sup>1</sup>

Our Medical Claim Attachments solution helps streamline claims processing by enabling required documents to be submitted electronically, maximizing efficiency for both providers and payers. With more than 800,000 providers and 2,100 health plans in our network — including nearly all government and commercial payers — we can send most claims/ attachments to their final destination without rerouting. This enables us to tie attachments to claims throughout the life cycle of each transaction, facilitating review and status checks. And because our solution makes it clear what attachments are required by each payer, the time spent submitting and reviewing incorrect documents is reduced.

- Supports numerous file formats, including .pdf, .jpg, .tif, and .gif
